THIS YEAR, NEARLY 750 VOLUNTEER COURT APPOINTED SPECIAL ADVOCATES (CASAS) SERVED ALMOST 1,000 CHILDREN WITH LONG-TERM ADVOCACY BY LEARNING ABOUT THEIR LIVING SITUATIONS, IDENTIFYING NEEDS AND PROVIDING RECOMMENDATIONS TO THE COURT THAT SERVE THE BEST INTEREST OF THE CHILD. CASA VOLUNTEERS WORK TO HELP CHILDREN FIND SAFE, PERMANENT HOMES, ENCOURAGE FAMILY VISITATION, AND SUPPORT CHILDREN'S MEDICAL, MENTAL HEALTH AND EDUCATIONAL NEEDS. VOLUNTEERS ALSO PROVIDE DAY OF COURT ADVOCACY FOR OVER 4,000 CHILDREN IN THE COURT'S SHELTER CARE PROGRAM. THE AGGREGATE VALUE OF SERVICES RENDERED BY CASA VOLUNTEERS THIS YEAR WAS \$2.9M.
