OUR MISSION

CASA of Los Angeles organizes the community to take action and advocate for children and families in LA County's overburdened child welfare and juvenile justice systems. Our vision is a Los Angeles in which all children and families impacted by the child welfare and juvenile justice systems have equitable access to the resources and support they need to thrive.

DEAR FRIENDS

This past year, CASA of Los Angeles embarked on a journey of continued commitment and innovation in advocating for the well-being of children within LA County's child welfare and juvenile justice systems, alongside their families. Our dedicated staff, volunteers, board members, and supporters collaborated to redefine our approach, introducing new ways to reach more children through one-to-one advocacy, redefining our programs, as well as expanding our marketing efforts to increase and diversify our volunteer base. Strengthening community ties and persistently advocating for systems and policy changes remained at the forefront of our mission.

Aligned with our supporters and partners, CASA/LA successfully served 1,061 unique children in FY2023 through our 903 Court Appointed Special Advocates (CASA volunteers). Our incredible CASA volunteers closed advocacy cases for 323 children, with many experiencing positive life-affirming outcomes, including reunification with their families, transitions to less restrictive placements, enrollment in suitable educational settings, and access to essential medical, emotional, and educational resources:

- 201 children moved to a more permanent placement
- 163 children were connected to specialized program or activity to support mental health and well-being
- 76 youth graduated high school or completed their GED or certificate of completion
- 235 children had increased time or connection with family members
- 210 children showed academic improvement or increased attendance in school

COURT APPOINTED SPECIAL ADVOCATES

(CASA) of Los Angeles is a community-supported organization of dedicated staff and volunteers who organize the community to work one-on-one with children and families in LA County's overburdened child welfare and juvenile justice systems.

Through an intentional, restorative and culturally responsive lens, CASA volunteers get to

- know the children and their circumstances
- show them that someone cares
- advocate for their best interests in court and in life
- encourage them to grow to their fullest potential
- and become involved in key issues in their life, especially permanent placement, education, and their mental and physical health.

While they are in our advocacy program, CASA children are meeting more of their educational goals. They are experiencing lower degrees of risk around their mental health and medical wellbeing. They are achieving higher rates of permanency. But most importantly, every child served by a CASA volunteer is connecting with a consistent adult.

CASA/LA strengthens our community, ensuring that children and families have equitable access to resources they need to thrive.

NOT YOUR ORDINARY VOLUNTEER ROLE

We mobilize community members of all backgrounds to advocate for our children and recruit the most reliable, dedicated, and compassionate people to join our team of CASA volunteers. Through strengths-based advocacy and life-affirming connections, we aim to change the trajectory of a child's life.

VOLUNTEER RECRUITMENT & OUTREACH

CASA/LA uses several methods and strategies to recruit volunteers, ranging from media outreach, advertising, online marketing, social media, earned media, and (often one of the most effective strategies) person-to-person word of mouth from current and former CASA volunteers. The recruited individuals receive in-person or online intensive training in order to perform trauma informed, culturally competent services. In addition, CASA/LA offers comprehensive ongoing training and support for new and continuing volunteers on issues unique to children in the child welfare system.

RESEARCH AND EVALUATION

In order to serve more children and to serve them well, CASA/LA has become a leader in implementing data systems for program evaluation, allowing us to improve the quality of service and administrative efficiency to our volunteers and to the youth that we serve. Through the implementation of the data management system ETO (Efforts to Outcomes), CASA/LA is able to track our volunteer-to-case assignment pipeline, and ultimately, the impact of CASA advocacy on the safety, permanency, and well-being of the children served.

CASA VOLUNTEER ADVOCACY EFFORTS

Provide one-to-one advocacy that is culturally responsive to a child's individualized needs

1:1

15 HOURS

Spend a minimum of 15 hours a month:

- Advocating for a child and maintaining regular contact with that child
- Communicating with case parties. Writing court reports and attending court hearings as needed
- Updating advocacy documentation on CASA/LA's online case management system

12 HOURS

CASA volunteers are required to complete a minimum of 12 hours of continuing education training each calendar year in order to stay abreast of new information, services, policies, and legislation that can impact their youth's situations, and in turn their advocacy.















EDUCATION

Olivia was a shy and reserved 15-year-old who had already weathered the storm of six social workers over the span of 18 months. Olivia was living in a home with seven other girls, and amidst the shuffle, she struggled to find her voice. That's when Adina entered her life. As her CASA volunteer, Adina recognized Olivia's need for stability and began a weekly FaceTime ritual with her. Although Olivia didn't always answer, Adina's consistency became a lifeline in the tumult of her life during the pandemic.

Through these virtual connections, Adina witnessed a remarkable transformation in Olivia. The once reserved teenager began to open up, gaining confidence and a newfound sense of agency. Olivia's journey to self-advocacy took a significant leap when she expressed her desire for unmonitored visits with her dad during a court hearing. Adina supported Olivia through this process and advocated for her in court, where the judge promptly granted her request. This allowed Olivia to feel a sense of control over her own life – something she had never experienced before.

Amidst the challenges of remote learning during the pandemic, Adina took on the role of an education advocate for Olivia. Recognizing that remote classes were not conducive to Olivia's learning style, Adina took proactive steps. She facilitated Olivia's transfer to a more supportive school, working closely with a teacher who understood and encouraged her. Despite initial resistance, Adina's persistence paid off, and Olivia could attend in-person classes, accumulating the credits needed for graduation.



Olivia's academic journey reached a triumphant culmination as she graduated high school on time, an achievement celebrated with an award for academic excellence. Adina's advocacy extended beyond education; she helped secure funding for Olivia's driver's education courses, enabling her to obtain a driver's license and further enhance her independence.

As Olivia approached the age of 18, Adina continued to guide her toward autonomy. Olivia transitioned to living with a family member, taking control of her life and decisions. Adina, having achieved her advocacy goals for Olivia, transitioned to supporting another youth, but the bond between Adina and Olivia endured. They continue to text, sharing updates, advice, and laughter, a testament to the enduring impact of their connection.



PHYSICAL AND MENTAL HEALTH



Alex's journey began at the tender age of eight when he was abruptly taken from his home. The trauma left him grappling with PTSD, manifesting in disruptive behavior at school. His desperate search for stability led him through three to four foster placements, each bringing its own set of uncertainties and anxieties.

By age 12, Alex was yearning for a sense of permanence. The prospect of adoption seemed promising, but an unexpected twist occurred when his biological mother reappeared, expressing a desire to reclaim her son. This hope was fleeting, as she vanished once again without fulfilling the necessary requirements. Alex was left in limbo when Chip entered his life as his CASA.

Chip played a pivotal role in Alex's life, not only as a guide through the complexities of the legal system but also as a pillar of support for his mental health. With a background in education, Chip took on the role of Alex's educational rights holder, advocating fiercely to keep him in a specific school tailored to his needs. Through relentless efforts, Chip secured transportation via Hop, Skip, Drive, ensuring Alex's continued academic success.

Alex's learning disability, particularly in math, posed an additional challenge, but Chip's determination knew no bounds. Collaborating with lawyers, DCFS, and educators, Chip orchestrated additional support to elevate Alex's academic performance, setting the stage for a future filled with possibilities.

Beyond the courtroom battles and academic pursuits, Chip embraced Alex's interests and passions, fostering a sense of normalcy and joy in his life. The duo embarked on explorations of English history, with Alex's fascination for monarchs such as Ann Bolin and Marie Antoinette. They delved into architecture and engineering, constructing virtual wonders in Minecraft and visiting buildings and viewing decks, capturing moments of happiness in the midst of uncertainty.

When Alex identified himself as a part of the LGBTQIA community, he found a safe space in his relationship with Chip. Together, they explored the realms of fashion, immersing themselves in the glamour of the Kardashians and the avant-garde world of Lady Gaga. Alex, with an artistic flair, sketched historical queens in elaborate gowns and created captivating comic books.

A weekly tradition emerged as Alex and Chip engaged in lively debates, discussing topics ranging from empires to kingdoms and democracy. Alex's insatiable curiosity extended to current events, transforming him into a self-proclaimed news junkie. A master of geography, capitals, and the model United Nations, Alex's intellect shone bright during their interactions.

Yet, beneath the surface of Alex's vibrant personality lay the common anxieties shared by many youths in foster care – uncertainties about the future, the trajectory of his life, and the elusive concept of permanence. Chip, recognizing the weight of these concerns, became not just a CASA volunteer but a confidant, helping Alex navigate the complexities of adolescence with a compassionate heart.

As June approached, marking the completion of Alex's legal guardianship process, Chip envisioned a future beyond the courtroom. His commitment to Alex extended beyond the confines of the legal system; he aspired to remain a mentor and friend, guiding Alex through the upcoming stages of his education and offering unwavering support as he embarked on the journey towards college – not just for Alex, but for himself. Chip noted, "Working with and hanging out with Alex expands my own horizons in many ways... I get as much out of the deal as he does."

PERMANANCY AND SAFETY

Cindy didn't become a CASA by chance. Her journey into the realm of child advocacy was driven by a deep-seated desire to make a difference in the lives of those often overlooked – teenagers.

Marissa was 12 when she first met Cindy, and already navigating great change in every aspect of her life. At first, Marissa was reclusive, clinging to the idea that her only friend was her twin sister. She and her sister often left their placement without permission. Marissa placed herself in the role of her sister's caretaker, and felt that if her sister wanted to run away, at least they would be together.

Marissa was eventually placed in a foster home separate from her twin. She felt alone, and was embarrassed to admit to her peers she was in the foster care system which made it difficult for her to make friends. Cindy recounts a moment when Marissa expressed fear of disappointment, a common sentiment among teenagers in the system. Cindy's reassurance that there was no reason to be ashamed, and that she would not be abandoned, became a pivotal anchor for Marissa.

Though the separation shook her, it ultimately helped Marissa blossom as an individual. Just as Cindy predicted, Marissa made friends because of who she was as a person – not a twin, not a foster child – but as a unique young woman that loves fashion, make-up, and the gym.

In Marissa's foster home, she learned how to be more independent, how to do financial budgeting, and how to find a job. She notes how Marissa thrived under the guidance of the adults in her life that took time to help her with anything she needed.

When she speaks of Marissa, Cindy beams with pride over how she has blossomed through the years they've worked together. "Marissa has learned to be an advocate for herself," Cindy states, "Whenever she doesn't understand something she knows to come to me and members of her team for clarity. She works hard to get things done."


Recognizing the bond Marissa and her sister had, and ultimately wanting her to feel a familial connection, Cindy supported Marissa's drive to find a placement closer to her twin. With Cindy's support, Marissa spoke to her foster mom and social worker. With their combined help, Marissa ultimately found and moved into a third foster home much closer to her sister. Cindy believes Marissa will stay in that placement through her upcoming 18th birthday.

Cindy's guidance helped Marissa understand that in order to have stability in her life, she must find a career. Marissa is on track to graduating high school, and has her mind set on pursuing a nursing degree at a local university. Cindy is confident Marissa will achieve anything she puts her mind to now and in the future.




